

Privacy Policy

Your safety is important to us. For this reason, any personal data that you will share with us is protected.

We, as RealPeople, aim to enlighten you about your rights regarding your processed data with this privacy and personal data protection policy regarding the subjects of which informations are processed, with what intent, to whom the collected data can be forwarded to and our data collection methods.

Your Collected Personal Data, Collection Method and Legal Reason

Your IP adress and user agent information will be automatically or manually collected, saved, stored and updated and will be processed under the service and contract agreement, only for the intention of analytics via certain technologies -such as cookies- and sometimes received from 3rd party service providers such as analytics providers, advertisement networks, search information providers and technology providers.

Purpose of Processing Your Personal Data

Your personal data that you share with us will be processed and updated during the contract and service and will be used only for analytics in order to fulfill the requirements of the services we offer in the best way to ensure that these services can be accessed and utilized by you at the maximum level to develop our services in line with your needs and to bring you together with wider service providers within legal frameworks, and with the intention of fullfilling legal obligations (personal data is to be shared with governemental and legal authorities upon request from said authorities).

To Whom The Collected Personal Data Can Be Transferred And For What Purposes

Your personal data you share with us can be transferred to third parties, institutions and organizations at home and abroad, with which we receive and/or provide services to carry out our activities, with whom we have contractual relations, with whom we cooperate, and to judicial and administrative authorities upon request, provided that necessary technical and administrative measures are taken.

Your Rights as the Person whose Personal Data is Processed

Pursuant to article 11 of the KVKK (Personal Data Protection Law), everyone can use the following rights by applying to the data controller:

- a. Learning whether personal data is processed or not,
- b. If personal data has been processed, requesting information about it,
- c. Learning the purpose of processing personal data and whether they are used in accordance with the purpose,
- d. Knowing the third parties to whom personal data is transferred at home or abroad,
- e. Requesting correction of personal data in case of incomplete or incorrect processing,
- f. Requesting the deletion or destruction of personal data,
- g. Requesting notification of the transactions made pursuant to subparagraphs (e) and (f) to third parties to whom personal data has been transferred,
- h. Objecting to the emergence of a result against the person himself by analyzing the processed data exclusively through automated systems,
- I. It has the right to demand the compensation of the damage in case of loss due to the unlawful processing of personal data.
